

Voluntary and community sector perspectives on safeguarding

We have so many wonderful voluntary sector organisations here in Haringey that work closely with our young people. Important when considering contextual safeguarding, and how that impacts teenagers more, when receiving safeguarding referrals or child protection concerns being raised. Children England has published a study of voluntary and community group's perspectives on child safeguarding in London in the context of changes in statutory service funding and policies. Findings from an online survey, targeted interviews and a cross-sector focus group with almost 100 organisations include: 86% reported an increase in the number of children, young people and families accessing their services; 61% of survey respondents cited an increase in child protection concerns and referrals; 53% of survey respondents cited an increase in referrals to child and adolescent mental health services (CAMHS).

Wellbeing mentoring initiative

One of the most impactful ways of reducing risk in young people is by building self-esteem, purpose and self-confidence. A great initiative here helping young people find their sporty side. Youth Sport Trust has launched an initiative to improve the physical, social and mental wellbeing of secondary school children in England. The project, which will be piloted in 25 schools, will see 250 young people, aged 15 to 18 act as mentors to a total of 750 young people experiencing mental health and wellbeing issues, supporting them in becoming physically active.

County lines - children forced to sell drugs

The BBC reports that about 4,000 teenagers from London are being exploited and trafficked every year to sell drugs in rural towns and cities. Known as “county lines”, gangs use children as young as 12 to traffic drugs using dedicated mobile phones or “lines”.

Review of children’s mental health services

When it comes to CSE we are so lucky to have the CSE/CSA CAMHS hub, offering MH support and court advocacy to young people. Please ensure you are accessing this vital service. The Care Quality Commission (CQC) has published a review looking at the quality and accessibility of mental health services for children and young people in England. Findings from the review, commissioned by the Prime Minister, include: the system is complex and fragmented - mental health care is funded, commissioned and provided by many different organisations that do not always work together in a joined-up way; children and young people expressed major concerns about how long they waited to access mental health support and that mental health care did not always feel person-centred and responsive to their needs; safety is seen as the greatest overall area of concern in specialist child and adolescent mental health services.

Young offenders

Really interesting study into what else is going on for the young people who become involved with the criminal justice system. The effects of trauma proves to be long lasting, and the fact that a quarter of participants found that social media had a strong impact on their choices in certainly something to consider. HM Inspectorate of Probation has published a report looking at the work done by Youth Offending Teams (YOTs) with young people convicted of violent and other serious offences. Examination of the case files of 115 young people who had committed violent, sexual and/or other offences where there were potential public protection issue found that: more than three in four had experienced emotional trauma or other distressing or disturbing things in their lives; and that In one in four of the cases inspected, the young person's use of social media was directly related to the offence they had committed.

Social media: malicious communication statistics

If you work with teenagers you will be aware of the issues social media can present, and the sexual offences that come with it. Massive increases seen in reporting of such crimes below. The BBC reports that figures obtained by BBC Yorkshire on offences of malicious communication recorded by police forces in England and Wales. Figures reported to 38 out of 43 police forces who responded to the request show that there were 79,372 offences recorded in 2016, up from 42,910 the year before.
